- I agree to adopt the Greyhound and will pay _____ (current owner) \$_____ before taking the greyhound into my home.
- I agree that I will change all microchip details from _____ (current owner) to my name and address within 14 days of adoption and that the fee incurred will be paid by me.
- Should the Greyhound become ill within ____ days after adoption, the _____ (current owner) will take all reasonable steps to treat or replace the animal – as deemed appropriate to the situation. I understand that all other treatments, during the life of the Greyhound, are my financial responsibility.
- I will, at my cost, provide the necessary care for the life of the greyhound in accordance with the *Animal Care and Protection Act 2011* (Qld) and will provide the necessary food, water, shelter and health care for the Greyhound.
- I will take full responsibility for the Greyhound, including responsibility for any damage or injury caused by the Greyhound.
- I will ensure that at any time the Greyhound is taken into a public place, it will always be appropriately muzzled, collared, leashed and controlled by me or a person authorized by me, in accordance with local law.
- I acknowledge the recommendation that the Greyhound should not enter any off leash public dog area, regardless of whether the Greyhound is on or off its leash. I acknowledge that off leash public dog areas include dog parks and off leash dog beach areas.
- I acknowledge the recommendation that the Greyhound will not be unleashed in any private area that is not fully enclosed.
- I will ensure, at my cost, that the Greyhound is registered (and remains registered) with all appropriate authorities, as required by law or regulation, including the relevant municipal authority in which I reside.
- The Greyhound will not be used for experimental or research purposes of any description, and I am not a dealer, nor the agent of a dealer.
- I understand the Greyhound is now de-registered from Racing and will not be able to return to racing.
