

GREYHOUND NOTIFICATION OF RETIREMENT

GA Rule 106(3)

At any time after the notification of the result of service pursuant to Rule 136, the **last registered owner** of the greyhound at the relevant time, shall, notify the Queensland Racing Integrity Commission (QRIC) by lodging the prescribed form, if the greyhound has transferred ownership, been retired as a pet or a breeding greyhound, been transferred to an adoption program, exported, surrendered to another agency, been humanely euthanized by a veterinary surgeon or deceased.
