Please provide a "Licence Style" colour photograph such as a passport photo. (upper body shot including your shoulders and head) Please note we **CANNOT** accept a scanned/photocopy of your actual Passport or Drivers Licence as your photograph.
- 3) Ensure all members who reside interstate are registered with the controlling body for the state in which they reside. Failure to do so will delay the processing of your registration.
- 4) Send your complete application to The Queensland Racing Integrity Commission (QRIC).

Submission of this application does not guarantee approval. Applications may be deferred for further investigation, interview or for any other reason at the QRIC's discretion.

Greyhound Syndicate Terms and Conditions

By making application to register a syndicate all members agree to the following Terms and Conditions:

1. That each Syndicate Member has read and agrees to be bound by the standards of the Queensland Racing Integrity Commission (QRIC) (which may change from time to time) available at <http://www.qric.qld.gov.au>.
2. That each Syndicate Member agrees to abide by the Greyhounds Australasia Rules and Local Rules of Racing which are available on the QRIC's website (and which may change from time to time) and each syndicate member agrees to continually update themselves in relation to any rule changes or additions to these instruments.
3. That each Syndicate Member will abide by all lawful directions issued by a Steward or an authorised officer of the QRIC which the Steward or officer is empowered to make or give.
4. That the QRIC reserves the right to request the applicant to provide a National Police Certificate.
5. That greyhound kennels are open to inspection by authorised officers of the QRIC or Stewards at any time.
6. That each Syndicate Member acknowledges and understands that in the interest of animal welfare, the wider racing community and the integrity of the industry, mistreatment of animals or animal cruelty is totally unacceptable, and will notify the QRIC immediately if they become aware, obtain knowledge or sighting of practices detrimental to an animal's wellbeing.
7. That each Syndicate Member acknowledges and understands that, as an owner, it is their primary responsibility to ensure the welfare and know the whereabouts of all Greyhounds that they own from whelping to retirement. This includes when they have placed a Greyhound in the care of another person.
8. That the QRIC may (without being in any way bound to do so) at any time and from time to time treat the Syndicate Manager (who has signed this application by way of confirmation) for the purposes of the above mentioned Rules and decisions (or any part of them) as the sole owner and/or as the sole representative of the syndicate in relation to any greyhound in respect of which the syndicate may be the nominator or have a proprietary interest whether as owner, lessee or otherwise, or have or exercise a right of control or disposition.
9. That each Syndicate Member hereby appoints the Syndicate Manager as their agent for the purposes of:
 - a. exercising any power;
 - b. making any decision; or
 - c. taking any action, on behalf of the syndicate or its members.
10. That an appointed Syndicate Manager may only have their appointment revoked upon the provision of written authority to the QRIC from a voting majority of the syndicate. This means that 51% of votes in a syndicate are required to affect change to that syndicate's structure. Where there are 2 members with 50% voting power each, both members are required to authorise any change.
11. That subject to the terms of this application, the syndicate members absolve the QRIC from any responsibility and/or claim for ownership which may arise, and any dispute or claim for prize money or progeny or other monetary earnings as a result of the appointed agent.
 - a. exercising any power;
 - b. making any decision; or
 - c. taking any action, on behalf of the syndicate or its members.
12. That the QRIC is absolved of any responsibility for any problems that may arise out of the way syndicates are managed or operated. Accordingly if any Syndicate Member feels aggrieved by the management or conduct of their syndicate or a particular Syndicate Member, he/she must be prepared to resolve the matter privately and without the assistance or support of the QRIC.
13. The QRIC is not liable for and takes no responsibility for any non-performance of any legal or equitable obligations of any members of a Syndicate whatsoever in relation to any syndicate agreement or other legal instrument.
14. Each Syndicate Member must hold a minimum of 1% voting power in the syndicate, with a total voting power not exceeding 100%.
15. The QRIC must be notified in writing of any change to the Syndicate (including the death of any member) within 7 days of the change occurring.
16. The Syndicate Manager has the authority to accept any prize money, trophies or other rewards on behalf of the Syndicate.
17. The QRIC maintains the right to reject any nominated Syndicate Name on any grounds whatsoever, including that the name may be offensive, may be unlawful, or may be at risk of breaching any of the QRIC's contractual obligations to other parties. Of those Syndicate Names that are accepted by the QRIC, the QRIC does not take any responsibility for Syndicate Names that have any relation or are similar to any trademark or patent. Should the syndicate be questioned in relation to the name this is the sole responsibility of the Syndicate and its members.
18. If any Syndicate Member or Syndicate Manager has ever been disqualified, suspended, warned off, fined or listed as a defaulter in connection with any code of racing, or in the past 5 years been convicted of a criminal offence punishable by fine or imprisonment, full details must accompany this application along with a recent National Police Certificate dated within one calendar month of this Application. If any Syndicate Member or Syndicate Manager is disqualified, suspended, warned off, fined, listed as a defaulter in connection with any code of racing or convicted of a criminal offence while a member of a greyhound syndicate, full details must be provided to the QRIC within 14 days of being notified of that having occurred.
19. Each Syndicate Member consents to the QRIC using and disclosing their personal information for any purpose in connection with the performance of The QRIC's functions and powers.
