GA Rule 106(3)

At any time after the registration of a litter, the last registered owner or person responsible for the greyhound at the relevant time, shall, notify controlling body [or delegated authority] by lodging the prescribed form:

(a) Within 10 working days, if that greyhound has transferred ownership

Submission of this application does not guarantee approval. Applications may be deferred for further investigation, interview or for any other reason at the QRIC's discretion. Should you have any queries in relation to the completion of this form, please contact Licensing on Ph. 1300 087 021.
