IMPORTANT

All colours must be capable of being distinguished by judges and stewards during a race.

Colours must be identical when viewed from back and front.

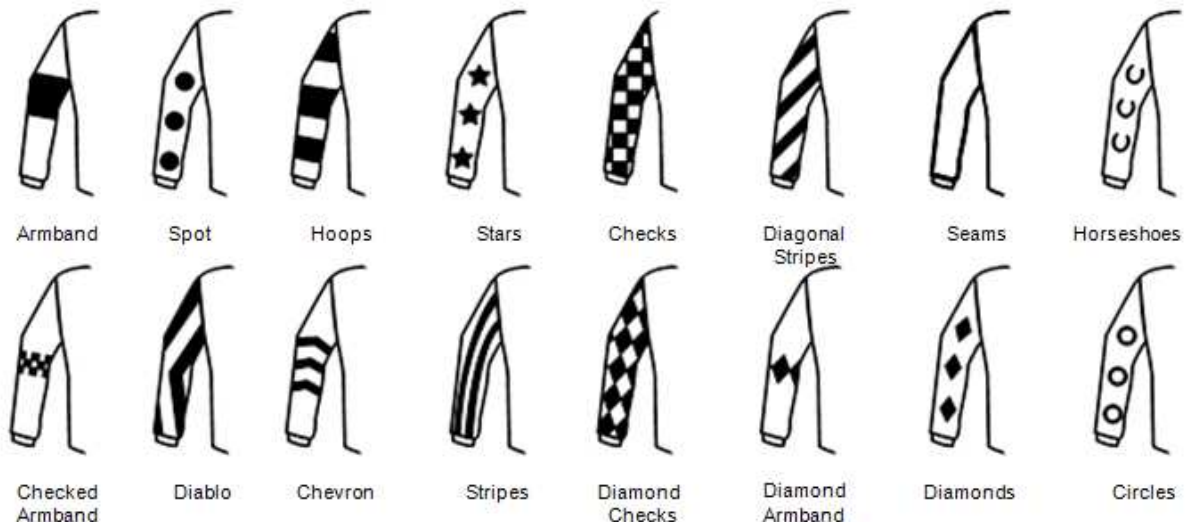
The following dimensions shall be used as a guide:

- Hoops, Stripes, V's and braces must not be less than 75mm wide.
- Multiple spots, stars, diamonds, checks, crossed or single sashes and armbands must not be less than 100mm.
- Bands & single stripe must not be less than 125mm.
- Single diamond, star, spot, horseshoe, lightning bolt must be no less than 280mm depth x 230mm width.
- Single Maltese cross, shamrock, cross or Lorraine should be not less than 280mm x 280mm.
- Other approved motifs/shapes should use the above sizes as a guide.
