

Corporate Bookmaker Application

The <u>Racing Integrity Act 2016</u> (the RIA) and <u>Racing Act 2002</u> (the RA) regulate the manner in which licensed racing bookmakers may undertake bookmaking in Queensland.

The RIA also contains specific provisions relating to the activities of licensed racing bookmaker's clerks. Significant penalties (including imprisonment) may be imposed for breaches of this Acts. As ignorance of the law is not a defence to such offences, you should gain a strong understanding of this of legislation.

Before proceeding to apply it is recommended that you take the time to familiarise yourself with the '<u>Standard for suitability of person to apply or hold Racing Bookmaker's Licences</u>

Application process

- All applications for a Corporate Bookmaker Licence must be approved by the Queensland Racing Integrity Commission (the Commission).
- 2) Completion of the application form requires:
 - •
 - A resume detailing current and past employment, including experience in wagering and racing of each business associate or executive associate of the Corporation.
 - Verified identification of each Director (i.e. 100 point identity verification check which may include a birth certificate or passport and a driver's licence or 18+ card), their Bookmaker licence status, and a National Police Check certificate.
- 3) An eligible corporation is one that is properly constituted in accordance with the Corporations Act 2001 (Cth)

Conditions of the Corporate Bookmaker Licence

In the event of such a licence being granted, we, the Directors agree:

- To observe and be bound by Race Club By laws and Track Regulations, Associations and Rules of Racing in force from time
 to time during the currency of such licence and also such directions as may from time to time be made or given by the
 Commission, Stewards or Officials of the Club.
- 2. That the licence may be revoked at any time by the Commission without giving any reason in accordance with the RIA and the Standard for suitability of persons to apply or hold Racing Bookmaker's Licences.
- 3. Not to make any public statement or comment concerning any matter currently the subject of investigation or inquiry before the Stewards or the Commission.
- 4. It is acknowledged that we are personally bound by the Rules of Racing. Any corporation or company, for whatever reason, shall not exempt us from our personal liability under the Rules of Racing, Standard for suitability of persons to apply or hold Racing Booker's Licences, or the *Racing Integrity Act 2016*.
- 5. To pay all fees due.
- 6. To furnish, at the conclusion of every race meeting at which the corporate bookmaker operates, a certificate stating the gross amount of all bets made with the bookmaker company in respect of such meeting, and to furnish with the Commission a certificate stating the gross amount of all bets made and the gross margin on all bets.
- 7. To make and keep, in respect of each race meeting at which the bookmaker company operates, a true record of all bets and to retain legible copies of the same for a period of six (6) months from the date of the meeting to which the same relates, and provide a copy to the Stewards at the completion of such race meeting or such earlier time as the Stewards may direct.
- 8. To authorise the Commission, or its authorised agent to inspect any documents in connection with the bookmaker company activities.
- 9. To maintain and keep a wages book, or other record, in which is set out the gross amount earned and net amount paid (with details of all deductions and holiday pay) each week to each member of staff for the term of the licence.
- 10. To adhere to all Commission directions and standards concerning the operation of the bookmaking business, including but not limited to the list of the Commission's Standards relating to Bookmakers and betting.
- 11. To apply to the Commission in writing (or complete the appropriate form) if the bookmaker company seeks:
 - To appoint a new Director;
 - To make any alteration in the shareholdings in the company.
- 12. To advise Commission in writing (or complete the appropriate form) if:
 - A Director (in the bookmaking company) dies or resigns; or
 - A shareholder (in the bookmaker company) dies or disposes of shares in the bookmaker company.
- 13. A bookmaker company may only trade or operate under a name which is registered with the Office of Fair Trading and approved by the Commission. Such approved name shall be displayed at all times on the Bookmakers stand, betting sheets, betting tickets, activity return forms and any other correspondence during the term of such licence.
- 14. That the bookmaker company structure is compliant with the RIA.

Unless otherwise authorised by the Commission, the following shall apply to a Bookmaker Company:-

- 15. The number of Directors at any one time shall not exceed four (4).
- 16. The number of shareholders at any one time shall not exceed twelve (12).
- 17. The Directors must hold a minimum stake in the company
 - as individuals 5 %
 - collectively 51%
- 18. At any race meeting at which a bookmaker company is fielding, a Director of the company is to be on the bookmakers stand at all times. However with approval from the Commission a licensed Bookmaker's Clerk may operate in the absence of a Director. Applications in writing, accompanied by the appropriate guarantees, outlining the circumstances preventing a Director being present must be lodged with the control body by 10.00am on the day preceding the race meeting.
- 20. Applications for a bookmaker company to operate at more than one race meeting on the same day, or on more than one stand within the same betting ring will be considered, provided that the company has:
 - the appropriate number of Directors (refer 15 above)
 - the appropriate level of guarantee (refer 18 above)

The Commission collects information about you when you submit this Application for Registration as a licensed person ("Application"), and in the course of related enquires of third parties for the purposes of the *Racing Integrity Act 2016* and *Racing Act 2002*. The Commission will use that information to assess your application and, if registration is approved, your ongoing status as a licensed person. To do that, the Commission may disclose your information to your employers (past, present or prospective) and other racing bodies. You do not have to supply the information requested in this Application, but if the information (or any part of it) is not provided your application may be rejected. In most cases, you can gain access and request that corrections be made to your information held by the Commission. By completing and submitting this Application, you authorise the Commission to collect, use and disclose information about you for the purposes described in this notice.

I certify that to the best of my knowledge and belief the particulars as outlined in this application are true and correct. I also declare that I understand that it is a serious offence under the *Racing Integrity Act 2016* to make a false declaration and that failure to accurately answer these questions may lead to this application being refused.

I understand that I am providing consent, under section 79(2)(c) of the *Racing Integrity Act 2016*, for each person the Corporation considers a business associate or an executive associate of the Corporation for each of the following:

- the taking of fingerprints;
- the Commission obtaining information about the associate; and
- the Commission investigating the background of the associate (including financial probity assessments).

I understand that this includes the obtaining of the types stated above for a person whom the Commission reasonably believes to be a business associate or an executive associate of the Corporation but whose consent does not accompany this application.
