#### 3. Offensive / Defensive

QRIC spoke about the concept of offensive/defensive public comment, whereby clubs and industry representatives provide comment in the media, particularly when there's an incident that brings the industry into disrepute.

The feedback from attendees was that they're happy to help QRIC with external communications but they would be hesitant to comment on individual cases.

# 4. Industry Participant Conduct

QRIC discussed concerns with some negative behaviour by industry participants, and proposed to work with industry representatives to identify collectively what type of conduct is expected.

The group acknowledged that the Rules of Racing outline expected participant conduct, however the rules are inconsistent across the three codes of racing, and it agreed that a clear set of standards would be beneficial.

QRIC proposed a consultative approach to explore the possibility of developing a policy or statement which outlines the expected conduct. The group agreed with this approach.

QRIC will seek nominations from SRG members to be involved in the consultative working group.

# 5. Licensing Standards Review

QRIC provided an update on the Licensing Standards Review, including that one of the key elements to be reviewed is the 'fit and proper person'.

QRIC will engage in open consultation with industry representatives to identify what's working and what needs improving. As part of the review, QRIC will conduct a jurisdictional analysis to compare Queensland's standards with other racing jurisdictions nationally and internationally.

The intended outcome of the Review is to establish a contemporary set of standards for Queensland whilst considering the Queensland context and what is best for our State.

# 6. Penalty Guidelines (THB, HAR, GHD) and Traceability Standard

QRIC provided an update on the draft Penalty Guidelines for GHD and THB and the updated HAR Penalty Guidelines as well as the new Equine Traceability Standard.

QRIC provided the group with an opportunity to submit feedback prior to the guidelines and standard coming into effect on 31 March 2023.

It is intended the guidelines will be utilised by the Racing Appeals Panel.

The Traceability Standard implements elements of the Martin Inquiry.

#### 7. Racing Appeals Panel update

QRIC provided an update on the Racing Appeals Panel (RAP). QRIC advised RAP will establish an independent set of practice notes and it is expected the panel will sit multiple times per week.

QRIC provided an outline of how a RAP hearing is likely to operate.



#### 8. Animal Care Strategy

QRIC proposed working with industry to discuss what animal care should look like across the three codes of racing. This discussion would help inform the development of a new industry strategy.

The group acknowledged that industry compliance with animal welfare standards needs to improve, although industry members generally know what is expected, an education campaign was touted as being beneficial.

QRIC will seek nominations from SRG members to be involved in an education program about better animal care.

### 9. Substance Control Strategy Video

QRIC shared the Substance Control Strategy video as an educational piece that will assist industry to better understand how swabs are taken across Queensland.

# 10. Key Issues / Opportunities

The attendees discussed the Alligator Blood issue, and QRIC provided an update noting it has gone to the Court of Appeal and a hearing date is yet to be set.

Greyhound on-track injury management was discussed and QRIC advised that it is undertaking additional training and education for on-track vets.

The topic of rehoming of greyhounds was discussed by the attendees. QRIC shared process improvements at the Greyhound Adoption Program to improve efficiencies. The benefits of these changes are coming through.

QRIC advised that there is a need for more people to adopt and foster retired greyhounds and reiterated the importance of appropriate greyhound care and welfare, including socialisation, through all aspects of the greyhound's life which will make a smooth transition for rehoming of retired greyhounds.
